# OF WATER RESOURCES IN SWIM-SM COUNTRIES

13-14 June 2012, Athens

# 1.1 Background

Within the scope of Work Package 1 (WP1) entitled "Water governance & mainstreaming", the EU-funded SWIM-SM project is performing several tasks with the aim to develop mechanisms and procedures to facilitate regional dialogue, consultations and exchange of experience among the most water intensive sectors such as agriculture, tourism and urban development.

To this effect, SWIM-SM is carrying out a regional review of national water plans and/or strategies (activity 1.1.1). The report aims to provide the PCs with an assessment and close-up look on the status of national water planning in one of the most arid regions of the world. This report is designed to move beyond the traditional description and compilation of information on national plans and strategies. The report aims to examine, analyze and interpret the compiled information in order to assess achievements, constraints, challenges and shortcomings of the current water plans and/or strategies, identify opportunities and formulate recommendations and socially sensitive policy options towards effective implementation of water plans and/or strategies in PCs within an IWRM context.

The outcomes of this analysis are intended to be used as a background material and food for thoughts to establish a dialogue among decision makers, including high level officials, from water and water relevant sectors to underline the necessity of mainstreaming and integration in water management. This dialogue shall be enriched through the involvement of eminent national and international experts on sustainable water resources management.

In this connection, SWIM-SM is planning to convene the regional workshop in Athens from 13 to 14 June 2012 to discuss the outcomes of the regional review and suggest policy options for further actions towards mainstreaming water in non-water sectors within IWRM context.

# 1.2 Objectives & expected results

# 1.2.1 Objectives

The main objective of the workshop is to review, discuss, complement and validate the findings of the regional review of national water plans and/or strategies with the view of suggesting a series of policy options for further actions towards mainstreaming water resources management in non-water sectors. The following are the specific objectives:

1. To discuss degree of success and achievements of PCs in planning and implementing IWRM principles such as level of participation of stakeholders, horizontal coordination, gender balance, institutional and legislative reforms, etc.

- 2. To deliberate the main constraints, shortcomings, and main gaps facing proper implementation of IWRM principles and the most applicable measures to bridge these gaps.
- 3. To discuss the main challenges to sustainable water resources management such as population growth, urbanization, climate change, inadequate financing, etc. and identify measures to overcome these challenges.
- 4. To examine available opportunities, discuss and agree on a series of measures, policy options and propose further measures to expedite implementation of IWRM principles with a main focus on mainstreaming sustainable water resources management in non-water sectors.

#### 1.2.2 Approach to meet workshop objectives

The targeted participants to this dialogue are national water and/or environment policy makers and officials, invited eminent experts and representatives of regional and international water programs. In order to achieve the meeting objectives, a highly dynamic, interactive, facilitated and participatory approach will be adopted, including the following:

- Power point presentations on the outcomes of SWIM review to stimulate discussions and identify priority areas for discussion.
- Review of selected case studies from three PCs.
- Briefs from PCs on national experience in achievements, challenges, constraints, opportunities and suggested policies for effective planning and implementation of IWRM.
- Facilitated round table discussions and brain storming to identify techno-economically and socially sensitive policy options to ensure mainstreaming of water management in non-water sectors.
- Presentations and interventions from invited international eminent experts to bring regional and international experience into perspective.

# 1.2.3 Expected Outcome

- A validated, complimented and/or amended report on regional review of national water plans and/or strategies;
- A proposed series of measures and policy options to expedite implementation of IWRM principles with a special emphasis on mainstreaming water management in non-water sectors.
- A dialogue is established between national water policy makers, experts and international experts.
